Chuck Klamer discussed the sidewalk project for 2010. The third request for installation has been sent to three property owners on Liberty Street.

Mayor Craig Moser applied for a sidewalk grant in the amount of \$100,000.00 to install sidewalks on Liberty Street to South Street. The grant application was a joint venture between the Village of Garrettsville and the James A. Garfield Schools.

Council reviewed the insurance options from Dawson.

Moved by Klamer, seconded by Patrick to approve Option 2 from Dawson Insurance.

Rick Patrick discussed the money that is owed by the owners of the Quail Run Property. The Clerk will send the amount that is owed to Solicitor Michele Stuck. Solicitor Michele Stuck will review the options the Village may have to collect the money that is owed.

Rick Patrick told Council the work at the Garrettsville Police Department is complete and looks very nice. Rick announced the resignation of part-time patrolman Mark Pfeiffer.
