The meeting was called to order by Mayor Craig Moser with Steve Hadzinsky, Bob Matson, Jeff Kaiser, Chuck Klamer, Rick Patrick, Karen Clyde, Solicitor Michele Stuck, Clerk Nancy Baldwin, Ericka Yoxall, Sherry Johnson, Austin Johnson, Dave Wensel and Valorie McCullough.

Moved by Patrick, seconded by Hadzinsky to approve the minutes of the May 12, 2010 as presented by the Clerk.

Moved by Clyde, seconded by Kaiser to pay the bills.

VOTE AYES—Unanimous

Revenue, Expenditure and Cash balance reports were reviewed.

Moved by Patrick, seconded by Hadzinsky to approve Ordinance 2010-29, An ordinance establishing zoning designations for 22.1749 acres of land annexed to the Village of Garrettsville.

Moved by Clyde, seconded by Klamer to suspend the rule that ordinances be fully and completely read on three different days and that Ordinance 2010-31 be placed on first reading and passed.

Moved by Clyde, seconded by Klamer to approve Ordinance 2010-31, An ordinance authorizing the Clerk of the Village of Garrettsville to transfer funds from certain accounts to balance the books.

Moved by Matson, seconded by Kaiser to table Ordinance 2010-32, A resolution authorizing participation in the Water Resource Restoration Sponsor Program in association with the Water Pollution Control Fund. (need more information)

Dave Wensel was present to discuss the placement of the Train Depot. Rick Patrick wanted to acquire property by the railroad. This would have given the Village a parking area and access to Head Water Trails. Dave Wensel suggested behind the Mill on Main Street. Mayor Moser told Dave the Village does not own that property. After a lengthy discussion Karen Clyde suggested that Dave do some research and come back to Council with a specific plan.

There was discussion on the Village of Garrettsville's web site. The Village had received three quotes to update the web site. Ericka Yoxall was present to answer any questions that Council might have about her quote.

Moved by Kaiser, seconded by Hadzinsky to approve the quote from Ericka Yoxall at a cost not exceed \$5000.00.

VOTE AYES—Unanimous

Steve Hadzinsky told Council that the Northgate sign would be coming down and they may not replace it. He told Council the sinkhole is back.

Chuck Klamer told Council James A. Garfield School District received an excellent rating for the third year in a row. Council commended Chuck Klamer and the James A. Garfield School District for a job well done.

Chuck Klamer discussed the sidewalks on Liberty Street. He would like to continue the sidewalks on Liberty Street and wants Council to make a decision on what side of the street the sidewalks should go. Karen Clyde said Council should pay for the installation of new sidewalks not the Village residents. There was discussion on charging both sides of the street. More discussion at the next Council meeting.

Chuck Klamer discussed purchasing trees to give to residents. The Village has been taking down trees that are dead or damaged. More discussion at the next Council meeting.

There was a lengthy discussion on the Irwin property. Mayor Moser sent a letter to Michele Ward Clayton and to date has not heard anything from her. Bob Matson asked Council what is the next step in the process. Solicitor Michele Stuck said a Public Hearing would need to be held; a certified letter needs to be sent to property owners and all lien holders. Solicitor Stuck will research this and get back with the Clerk on when the Public Hearing can be set.

Mayor Moser told Council about a complaint on Wolff Drive about an ATV making too much noise. Solicitor Michele Stuck will research this and discuss options at the next Council meeting.

Mayor Moser asked Council for authorization to do some resurfacing at the basketball court on South Street and seal coating at the Street Department, the Village Hall and the Police Department parking lots at a cost not to exceed \$15,000.00.

Moved by Matson, seconded Clyde to approve the resurfacing of the basketball court on South Street and seal coating of the Street Department, the Village Hall and the Police Department parking lots at a cost not to exceed \$15,000.00.

Rick Patrick told Council the Chamber cookout will be held at his house on August 12, 2010. Summerfest is moving along. Rick gave Council a report of the Parks in the Village of Garrettsville. The report discusses what needs to be done to improve the parks.

Rick Patrick asked Council about placing toilet motion valves at the park on South Street at a cost of \$1950.00. Council agreed.
